

- 1. The tendering document may be obtained from the office of Mahatma Gandhi Government Engineering College Kotla (Jeori), Rampur Bushahr, District Shimla (H.P.) 172101 during office hours namely, from 10.00 hrs to 17.00 hrs, on all working days on the submission of a written application to the above office and upon payment of a non-refundable fee of Rs. 500/- (five hundred) in the form of a demand draft from any nationalized bank in favour of Director/ Principal Mahatma Gandhi Government Engineering College Kotla (Jeori) camp at J.N.E.C. Sundernagar, Distt. Mandi (H.P.) Payable at Sundernagar. The firms can also download the tender document from the institution website, i.e. www.mggec.ac.in and are required to submit a demand draft of Rs. 500/- non-refundable in the favour of Director/Principal, Mahatma Gandhi Government Engineering College Kotla (Jeori) District Shimla (H.P.) payable at Sundernagar.

- 3. Tenders will be opened in the presence of bidder or their representatives who may wish to attend the meeting on the specified date and time.
- 4. In the event of the date specified for bid receipt and opening being declared as a closed holiday, the due date for submission of bids and opening of bids will be the following working day at the appointed time and place.

TERMS AND CONDITIONS

- 1. Mahatma Gandhi Government Engineering College Kotla (Jeori) Rampur Bushahr District Shimla (H.P) 172101 invites sealed tenders for running Boys Hostel Mess on fixed cost basis in the premises of institute from reputed contractors/societies/firms/agencies etc. The tender document may either be obtained from the office of the institute on all working days or may also be downloaded from the institute website i.e. www.mggec.ac.in.
- 2. The contract will be awarded for a period of 11th months at the first instance. However, extension for more 11th may be granted subject to satisfactory performance certified by "Mess Committee" duly constituted by competent authority.
- 3. The contract shall be deemed to be bare contract only of the said mess. The overall control and superintendence shall remain vested in the undersigned whose officials at all reasonable hours shall be entitled to inspect the said mess about its bonafide use.
- 4. Sale or use of tobacco products, alcoholic products and other intoxicants are strictly prohibited. Playing cards and smoking is prohibited in the premises.
- 5. The contractor shall not be entitled to allow any other person to occupy the mess or to use any part thereof. The contractor shall not admit any person into partnership or become partner or to let or sub-let the mess.
- 6. The sealed quotations should reach the institute, latest by 07.08.2023 upto 1:00 PM. The bid will be opened on 07.08.2023 at 03:30 PM at in the administrative block of the institute in the presence of the bidder's or their authorized representative(s), who will be present at the scheduled date and time.
- 7. To keep record of inspections, the mess contractor shall maintain an inspection book. The contractor shall display the menu at appropriate places in the mess. The contractor himself shall be responsible for the recovery of mess dues from students based on taking actual meals in the mess.
- 8. In case of unsatisfactory service or misbehavior by the contractor or his employees, the contract may be terminated at any time by the Director-cum- Principal of the Institution after giving one month's notice.
- 9. The items served by the contractor should be of a good quality. The contractor should use only basmati rice and the basmati rice should not be of the size less than half grain. The mess committee will ensure maintenance of proper hygienic conditions and quality of the food served by the contractor. Edible oil for fry items should not be reused. It should be fresh for every time.
- 10. The special light food (like: Khichadi, dalia and hot water) should be served for sick students on request in advance.
- 11. Cooking should be in hostel mess only, no outside cooked food/except Bakery items shall be allowed.
- 12. The monthly rent will have to deposit before 10th (Date) of each month failing which double rent will be charged for that month.

13. The contractor shall provide adequate number of mess servants (not below the age of 18 years) in the ratio of 1:25 students having at least 02 mess attendants, 01 cook and 01 supervisor. All employees should be clean, neatly dressed, medically & physically fit as well civil, sober and honest in their dealings with the students, staff and others. The contractor will be responsible for the conduct and behavior of the servants under his employment. However, the contractor should provide the necessary details of all its employees (permanent, temporary, casual) to the institute. All the employees should be police verified. Medical fitness certificates of all the employees have to be submitted to the institute.

14. Employment of child labour (below 18 years) is totally prohibited.

- 15. This institute reserves the right to recover/adjust any amount which may be due from the contractor from performance security deposit.
- 16. The sanitation of kitchen, service area, toilets shall be sole responsibility of the contractor. All the items stored or served shall be properly kept to prevent contamination by flies and dust. The cleanliness of water storage tanks used for the mess is to be done by the contractor himself from time to time.
- 17. All breakage or damage to hostel mess property shall be made good by the contractor. Performance security of Rs. 40,000/-(Forty Thousand only) has to be deposited by the successful bidder at the time of agreement.
- 18. The performance security shall be in shape of F.D.R. duly pledged for at least 2 years in the name of the Director-cum-Principal, Mahatma Gandhi Govt. Engg. College Kotla (Jeori), Distt. Shimla (H.P.) and shall be valid for 21 days beyond the contract obligations.
- 19. Gas connection and furniture shall be provided by the institute whereas utensils etc. as per the requirement shall have to be arranged by the contractor. Maintenance and repair of mess property shall be sole responsibility of the contractor and he will return the same to the institution in perfect condition on the termination of the contract.
- 20. The contractor will return filled gas cylinders at the end of contract.
- 21. All the filled cylinders should not be placed inside the kitchen or mess area. In the event of breach of this clause, the undersigned shall be competent to cover up the losses from the performance security deposited by the contractor.
- 22. While using gas & electric appliances, due precaution to ensure safety of the building against fire break may be taken. In the eventuality of any laxity on this account, the amount of loss shall be recoverable from the contractor.
- 23. The contractor shall be responsible towards his/her workers for any injury/causality while working in the mess. This institute will not be responsible and liable for any compensation whatever.
- 24. The contractor shall not have a right to close the mess during holidays or vacation, pandemic period without prior permission of incharge of mess committee as the mess facility may be required during these days.
- 25. The contractor shall be responsible for depositing of mess rent with the cashier of this institute on or before 10th of every month @ of Rs. 3000/- (Three thousand only) per month for 11 months of the year. Electricity charges shall be paid as per the actual usage and water charges @ Rs. 300/- (Three hundred only) per month.
- Quality of food/services provided will be inspected / checked from time to time and if found unsatisfactory, the contract may be cancelled at any time by the institute with/ without furnishing any notice. Decision of the Director/Principal, Mahatma Gandhi Government Engineering College Kotla (Jeori) Distt. Shimla (H.P) with regard to determining the quality of food/service etc. rendered by the contractor shall be final and acceptable to contractor.
 - 27. The contractor shall not use any electrical appliances except Electrical Tubes, Fans, Fridge, Water

Cooler, Electrical Chimney and Electrical grinder.

28. Employees of Mahatma Gandhi Govt. Engineering College or their family members are not eligible to participate in the tender. A 'No-Relation Certificate' as per prescribed format (Annexure I) has to be mandatorily submitted by the Bidder along with bid on his letter head.

29. The bidders are advised to quote rates reasonable and in harmony with the quality of the Mess Menu. The unreasonably low rates may attract disqualification. The decision of the competent

authority in this regard will be full and final and binding on all bidders.

30. The tenderer must have prior experience of at least 1 year of running such mess/canteen in Govt. or other reputed organization in present time (not in earlier than five years) and must enclose latest certificate/documentary evidence in this regard. The experience certificate duly signed and stamped by the issuing authority will be considered only.

31. The contractor should have valid/functional PAN, GST and FSSAI registration. Moreover,

contractor shall ensure that his/her employees are covered under ESI and EPF.

32. The contractor/service shall be governed by the relevant statues/acts/rules of Govt. of India or /and Govt. of HP, as the case may be.

- 33. If required, the evaluation committee can act as negotiation committee for the purpose of award of contract.
- 34. Bidders are advised to inspect the available premises/resources before quoting the rates on any working day.
- 35. The tender shall be evaluated on the basis of rates quoted per day. In case lowest bidder is not found suitable or disqualified, the tender can be awarded to the next higher bidder. The decision of the competent authority in all the matters shall be final.
- 36. The Director cum Principal reserves the right to modify, impose or relax any clause in the terms and conditions.
- 37. The Director-cum-Principal, Mahatma Gandhi Govt. Engg. College Kotla (Jeori), Distt. Shimla (H.P.) reserves the right to accept or reject all or any of the tender without assigning any reason, whatsoever, and without any prior notice to the bidder.
- 38. The tenderer should furnish Earnest Money Deposit (EMD) of Rs. 25,000/- (Rs. Twenty five thousand only) along with tender in the form of DD/FDR from any Nationalized Bank drawn in favour of Director cum Principal, Mahatma Gandhi Govt. Engg. College, Kotla (Jeori) otherwise the tender will not be considered. The amount of EMD shall be adjustable towards performance security deposits of successful bidder.
- 39. The successful bidder shall furnish the required performance security and execute an agreementon a non-judicial stamp paper (embodying the Terms & Conditions of the Tender) within 15 days from the date of acceptance of the agreement.
- 40. The Director/Principal, Mahatma Gandhi Government Engineering College Kotla (Jeori) Distt. Shimla (H.P) reserve the right of offering the work even if single bid/tender is received.
- 41. It will be the responsibility of mess contractor to comply with all formalities of labour department including obtaining necessary labour license (if applicable) of the Govt. of Himachal Pradesh of the current works. In case of non-compliance of this, penalty as per government norms may be imposed on the contractor.
- 42. For all disputes, the jurisdiction shall be at Rampur Bushahr, District Shimla, H.P.

43. Force Majeure shall be applicable as the case may be.

44. Institution has hired hostel/ accommodation facilities for students and staff in HTI complex Kotla (Jeori) from SJVN Ltd. Jhakri on lease/Agreement basis for 11th months tenure. In

case, SJVN terminates the lease during lease period, the contractor shall close the mess service. The contractor will be informed in advance notice of one month by The Director-cum-Principal MGGEC Kotla (Jeori), Distt. Shimla (H.P.)

- 45. The tenderer should submit copies of all documents duly signed in three sealed envelopes as per requirement of this document as under: -
 - First sealed envelope should be super-scribed as "Technical Bid-Mess in Boys Hostel".
 - ii) Second sealed envelope should be super-scribed as "Financial Bid-Mess in Boys Hostel".
